

Risk Management/Insurance

01 The Governing Board strongly supports a risk management program that
02 protects District resources and promotes the safety of students, staff and the
03 public.
04

06 The Superintendent or designee shall establish a risk management program
07 that uses effective safety and loss control practices. The District shall strive to
08 keep its liability at a minimum and its insurance premiums as low as possible
09 while maintaining adequate protection. To determine the most economical
10 means of insuring the District consistent with required services, the
11 Superintendent or designee shall annually review the District's options for
12 obtaining coverage, including qualified insurance agents, a joint powers
13 agency, self-insurance or a combination of these means.

17 The Board reserves the right to remove an insurance agent-of-record or a
18 participating agent whenever, in the judgment of the Board, such action
19 becomes desirable for the best interests of the District.

22 To attempt to minimize the District's exposure to liability, the Board shall adopt
23 clear policies related to discrimination, harassment, safety procedures, and the
24 timely handling of claims. The Superintendent or designee shall ensure that
25 these policies and related procedures are enforced fairly and consistently.
