01 The Governing Board believes that all citizens have a responsibility to be
02 stewards of the environment and desires to integrate environmental
03 accountability into all District operations. The Superintendent or designee shall
04 promote green school practices that conserve natural resources, reduce the
05 impact of District operations on the environment, and protect the health of
06 students, staff, and community.

09 The Superintendent or designee may involve District and site administrators
10 and operations and maintenance staff; representatives of local governmental
11 agencies, utilities, solid waste and recycling companies, and community
12 organizations; health professionals; and/or others as appropriate in the
13 assessment of current District operations and the development of strategies to
14 improve the environmental impact of District operations.
