# Key Areas of Study as of May 23, 2019

- Existing Reports

The FAC has focused its early meetings on reviewing an extensive number of pre-existing district facility reports. These reports include:

Capital Facilities Needs Assessment
Safety and Security Assessment
District Budget and State Funding
Deferred Maintenance Report
Traffic Studies

- Election Consideration Strategies

Joy Tatarka of TBWB shared a presentation regarding election considerations should the FAC recommend financing which requires election approval.

# Key Areas of Study as of May 23, 2019

- Site Tours

The committee completed extensive tours of all 4 school sites.

- Historical Context

The committee also hosted Scott Jenkins, former SMUSD board member and oversight chair and Tim Wright, former oversight chair. Both had historical perspective on the last construction effort; what worked, what did not work and recommendations should further construction be contemplated. Andy Barth will be joining our June 13, 2019 meeting.

- Financing alternatives for capital construction/renovation
- Construction timeline options and the implications to overall cost and educational programming
- Public contracting considerations and requirements
- Additional follow up on facilities presentations and district budgeting
- Deferred maintenance funding needs
- School site needs review as identified by each site principal
- The future of education and the implications to school sites

# Early Observations

- District sites have good exterior presence.
- The district has clearly made an effort to ensure that prior construction (1996-2006) is maintained.
- The committee has noted the need for some additional work. Largely, the work identified would:
  - Improve educational experience and/or site safety and security
  - Replace or substantially repair large deferred maintenance items; air conditioning units, sections of roofs, etc.
  - Renovate areas of the district that were not included in prior construction projects
  - Sustainable plan to fund and complete all deferred maintenance
