20 The Governing Board believes that assemblies and special events should promote a  
21 positive school climate and be related to the District's educational program. Assemblies  
22 may provide information that supplements the District's curriculum or may showcase  
23 student achievement in academics, athletics, music, art, drama, or other extracurricular  
24 or cocurricular activities.
