ACCEPTANCE OF BID F 01-17/18, HUNTINGTON MIDDLE SCHOOL PHASE III – CONSTRUCTION OF BARTH ATHLETICS COMPLEX BID DIVISION #6 – DOORS AND HARDWARE

It is recommended that the Board of Education accept the Bid F 01-17/18, Huntington Middle School Phase III – Construction of Barth Athletics Complex Bid Division #6 –Doors and Hardware as complete and authorize the release of retention to Construction Hardware Company following the required waiting period.

Background

At its regularly scheduled meeting on September 12, 2017, the Board of Education voted to award Bid F 01-17/18, Huntington Middle School Phase III – Construction of Barth Athletics Complex Bid Division #6 Doors and Hardware, in the Base Bid #1 amount of \$143,200 and the Base Bid #2 amount of \$5,400 to Construction Hardware Company.

Recommendation

The work of this Bid Division has been completed, and a Notice of Completion has been prepared for the Board's consideration. It is appropriate for the Governing Board to accept this Contract as complete at this time so that the 5 percent fund retention may be released following the Code mandated waiting period. There were no change orders for the Bid Division.
