Projected Budget Deficit

2020-21 Projections

- July, 2019 - Budget Deficit \$2.5 M
- December 2019 - Budget Deficit \$3 M

Increased Pension Cost

2020-21

- CalSTRS 18.4%
- Will continue to increase annually to 25%
- CalPERS 22.68%
- Will continue to increase annually to 28%

Increased H&W Costs

2020-21

- Maximum District Contribution \$16,975

Budget Variables May-August, 2020

- What will Governor Newsom's May Revise tell us?
 - Will we be given a predicted % reduction?
- Will there be any federal relief coming to schools? How much?
- What will be in the August Revise when tax receipts are known?
 - Current prediction is a negative 20-22%
- Will schools physically reopen in the Fall?
 - If they do, what will enrollment look like?
 - How will schools be funded -- enrollment or ADA?
 - Will Sacramento waive the Grade Span Adjustment class size for full funding?
- If schools do not reopen physically, how will that impact services?
 - Will the State continue to pay "non-essential" employees?
 - Will we have to conduct additional layoffs?
